- From Minutes of Probate Court, Book 5: p. 221. May 26. 1859. Marion Read, a legatee mentioned
 - in the will of Elias Read, made application that his legacy under said will be distributed to him. Citation to Elizabeth Read, executor of said will. notifying her of the hearing of said petition.

p. 159. June 14, 1845. Wm. F. Fountain, Joshua Philen & Sidney Philen, heirs of Feter Philen, dec'd, vs.

Manassah Philen, administrator of Wm. Philen, dec'd.

"In this case, on application, it is ordered that notice issue to Manageah Philan, adm. of estate of Wm. Philan, dec'd, to appear at next term of court, and file his accounts with said minors for a final settlement of the guardianship of said Wm. Philan, dec'd, in his lifetime, with said minors." [?]

p. 175. Aug. 18, 1845. Wm. Fountain and wife, and others, versus Hanassah Philen, adm. of Wm. Philen, dec'd. Settlement of the guardianship of Wm. Philen, in his lifetime, with Wm. Fountain and wife, and others is continued till 3rd Hon. Sept. next.

p. 36. Dec. 16, 1844. Wm. F. Fountain was appointed guardian of the minor heirs of Peter Philen. viz.

Harrison Philen Chapman Philen Isham Philen Jackson Philen

p. 183. Aug. 18, 1845. The minor heirs of Peter Philen are named again: Catherine Philen who married Wm. F. Fountain; Joshua Philen; Jackson Philen; and Chapman Philen. Wm. Philen, dec'd, had been their guardian.

Estate of Brittain Belk, Wilcox Co.

From Minutes of Probate Court, Book One:

p. 111. Nov. 13, 1826. Sarah, widow of Brittain Belk. dec'd, applied to be made administratrix of his estate, and asked that Stephen Day, a citizen of Wilcox Co., be jointly concerned in said administration. Bond for \$1200.00 with Wm. Fisher and Blakely Higginbotham as their securities.

Compiler's note: There are 7 documents relating to this estate in MPC Book 2. I read them all, but found no list of heirs. Stephen Day was still adm. in 1830.

From Minutes of Probate Court, Book 3, p. 157:

17 July, 1837. Sarah Belk, guardian of Darling, Mary and William Belk, heirs of Brittain Belk, dec'd, asked to have her appointment as guardian amended so as to include Augy Myram Belk, minor heir of Brittain Belk, who is over 14 years of age; also to show that said Brittain Belk was the son of heir of Darling Belk, dec'd, late of Hecklinburg Co., N. C. She gave bond for \$300.00 with Green A. Fisher and Geo. D. Fisher as her securities.

From Manutes of Probate Court, Book 5:

p. 196. Aug. 18, 1845. Came Sarah Belk, guardian of the minors heirs of Darling Belk, dec'd, and filed the rec'ts of H. J. Belk, M. A. Tolbert, and M. Z. Belk, heirs at law of said decedent's estate.
